ITEM 720-BH

(Cancels Item 720-BG)

KRL CHARGES FOR USE, NON-USE/SET-BACK AND DETENTION ON HEAVY CAPACITY OR SPECIAL TYPE FLAT CAR

APPLICATION

- Charges assessed under this item will accrue to KRL and will be billed and are payable to Kasgro Rail Lines, 121 Rundle Rd, New Castle, PA 16102 or to a Kasgro assigned banking institution.
- The Use Rate will apply on KRL cars when these cars are furnished for use in line-haul or switching service for all carriers.
- Charges assessed under this item will be in addition to any other charges, including normal demurrage charges.
- These charges will apply at or between all stations in the United States, and/or Canada and/or Mexico.
- If a KRL car is not listed in this item but is listed in the HEAVY DUTY AND SPECIAL FLAT CAR section of Tariff RER 6414 series, the Use Rate will be that provided for Rate Group H. Also, the additional Non-use/Set-back Rate Group H charges will apply to the unlisted car.
- Any KRL car ordered and furnished must move free of empty transportation charges on carriers that participate in the loaded move.

APPLICATION

The 30 Day Use Rate will begin when the car is either "Actually Placed" for loading or on the pre-set Load Date, whichever is the latter.

Note, if a car should load prior to the pre-set loading date, then charges will begin from that time.

These rates will be applicable until the car is released empty, deck cleaned and ordered out of facility to servicing railroad.

NON-USE/SET-BACK AND CANCELLATION CHARGES

(See Note 2)

A Load Date can be adjusted **ONCE** without any penalty, provided the adjustment is given to Kisoro at least **ONE FULL WEEK** or more prior to the original Load Date **AND** the adjustment is less than **ONE WEEK** from the original Load Date.

Any attempt to adjust the Load Date within **LESS THAN ONE WEEK** prior to the pre-determined Load Date will not be permitted.

Any **SECOND** Adjustment will be subject to a Set-Back Charge as outlined below, unless the customer prefers to have the Initial 30-Day period being as per the **FIRST** adjusted date.

SET BACK CHARGE

If a car Load Date is adjusted outside of the **ONE WEEK** allowance, the shipper is subject to a Set-Back Charge as follows:

8-15 Days adjustment from original Load Date.....	50% of the Initial 30 Day Use Rate
16-29 Days adjustment from original Load Date.....	75% of the Initial 30 Day Use Rate
30-44 Days adjustment from original Load Date.....	Full Initial 30 Day Use Rate
45 Days and beyond original Load Date.....	A daily prorated rate based on the 30 Day Use Rate will apply to each day.

If a car is in route to the loading point, as requested by the shipper and/or railroad, and the car is cancelled a Cancellation Charge of 50% of the Initial 30 Day Use Rate will be assessed against the shipper.

If a car arrives at the loading point and is then cancelled, **FULL** Initial 30 Day Use Rate charge will be applied as a Cancellation Charge against the shipper.

Note 2: In addition to the Non-Use/Set Back and Cancellation Charges, any applicable charges from the railroad/railroads involved in the movement of such car/cars, including, but not limited to transportation, switching, or other railroad ancillary charges will be the responsibility of the shipper or party ordering the car.
